**COMPLETE RELEASE & WAIVER OF LIABILITY, ASSUMPTION OF RISK
BY PARTICIPANT AND INDEMNITY AGREEMENT**

READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. Your signature indicates that you understand it and agree to its terms and conditions. By signing this agreement you (and your minor child) are giving up certain legal rights. These include the right to sue or to recover damages in case of injury, death, disease or property damage for any reason including but not limited to the negligence of the La Pine Rodeo Association, its owner, employees and agents, volunteers, officers, or board of directors, etc. Hereinafter called "releases".

I am signing this freely and voluntarily and consideration for allowing me and my minor child/children to handle and ride a horse and on behalf of myself, my minor child/children and to include our personal representatives, heirs, next of kin, spouse and assigns:

1. Acknowledge that this activity is inherently dangerous and may result in serious injury and/or death. Horses/mules and livestock may, without warning or any apparent cause, buck, stumble, trip roll fall, rear, bite, kick, run, become startled and surprised, make severe and unpredictable movements, spook, jump over obstacles and fences, step on a person's foot, push or shove a person, run a person into a wall or side rail, etc. Additionally, I understand that saddles and bridles may loosen or break. All of the above may cause a rider to fall, or be jolted and may result in serious injury and/or death;
2. Acknowledge that horseback riding is an inherently dangerous activity and that it involves many risks that may cause serious injury and in some cases death, because of the unpredictable nature and irrational behavior of horses regardless of their training, guidance and past performance;

I, _____ HEREBY VOLUNTARILY ASSUME THE RISK AND DANGER OF INJURY AND/OR DEATH INHERENT IN THE RIDING OF A HORSE/MULE OR OTHER LIVESTOCK AND THE USE OF SADDLES, BRIDLES, AND ANY OTHER EQUIPMENT AND GEAR PROVIDED TO ME BY LA PINE RODEO ASSOCIATION.

I, _____, hereby agree to release and forever discharge and hereby promise not to sue La Pine Rodeo Association, any of its agents, employees, directors, volunteers, officers, board of directors, or owner for any loss, damage or injury (including death) or costs to me or my child's person or property arising out of the activity of riding and handling a horse/mule or other livestock and for the use of saddles, bridles, equipment or gear provided by the La Pine Rodeo Association.

I, _____, hereby release the La Pine Rodeo Association and all persons named above from any claim that any person was negligent in connection with my or my child's riding of any horse/mule or other livestock including but not limited to any training, selection of horse/mule or livestock and any claim of negligence in the maintenance, care, fit for the adjusting of any saddles, bridles or other equipment or any instruction and explanation on any riding skills or leading or supervising riders which resulted in personal injury, loss, damage, injury, death or any of the above.

I, _____, hereby agree to indemnify and save and hold harmless the La Pine Rodeo Association, any of its agents, employees, directors, volunteers, officers, board of directors, owner, and all others connected herewith from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with mine or my minor child's handling or riding of a horse/mule or livestock and or the use of any saddles, bridles, equipment or gear provided therewith resulting from or contributing to in any way by own negligence.

I, _____, hereby expressly agree that the foregoing Release and Assumption of Risk and Indemnity Agreement is governed by the laws of the State of Oregon and is intended to be as general, broad and inclusive as possible be permitted by Oregon Law. In the event any portion of this agreement is determined to be invalid or unenforceable for any reason, the balance of this agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.

I, _____, hereby acknowledge that this document is a contract for valuable consideration and I agree that if a lawsuit is filed against La Pine Rodeo Association, any of its agents, employees, directors, volunteers, officers, board of directors, or owner for any injury or damage in breach of this contract I will be responsible for paying all attorney fees together with court costs both at trial and upon any appeal in defending any such action.

I UNDERSTAND THAT IT IS A PROMISE NOT TO SUE AND TO RELEASE LA PINE RODEO ASSOCIATION, THE OWNER, EMPLOYEES, AGENTS, VOLUNTEERS, DIRECTORS, OFFICERS, AND BOARD OF DIRECTORS FROM ALL CLAIMS. I HAVE MADE A FREE AND DELIBERATE CHOICE TO SIGN THIS RELEASE, WAIVER AND ASSUMPTION OF RISK AND INDEMNITY AGREEMENT. I AM SIGNING THIS AGREEMENT FREELY AND VOLUNTARILY. I HAVE BEEN ADVISED TO SEEK MY OWN INDEPENDENT LEGAL ADVICE AT MY OWN EXPENSE PRIOR TO SIGNING THIS CONTRACT.
